Conflict of Laws - Prof. Rosen

Welcome to Conflict of Laws! The casebook is Kay, Kramer, Roosevelt & Franklin, Conflicts of Laws (10th ed.), together with any supplement that may be available. For our first class, please prepare the following:

- a. Introduction (pp 3-6)
- b. Review Pennoyer v. Neff (from Civil Procedure)
- c. Alabama Great Southern R.R. Co. v. Carroll (pp 7-10) + notes (pp 9-19)
- d. Milliken v. Pratt (pp 19-22) + notes (pp 23-28). Do not read the very difficult hypothetical in note 7 (pp 26-27).
- e. Review two other cases you've studied in other courses:
 1. Erie RR Co v. Tompkins (from Civil Procedure)
 2. Justice Jackson's concurrence from Youngstown Sheet and Tube Company v Sawyer (from Constitutional Law). If you haven't yet taken Constitutional Law, you need not look at this case.

Welcome to Remedies. The casebook is Laycock, Modern American Remedies (CONCISE 4th ed. 2012), ISBN 978-1-4548-1255-5. We will begin the course with a consideration of damages. Here are the first two assignments (page references are to the casebook):
